**ORDER**

This matter having come before the Court on April 14, 2023 on Proposed Intervenor Jodi White Jones's Motion to Intervene and Motion for Order Preserving Claimant's Rights, the Parties present through counsel and the Court duly advised in the premises, IT IS HEREBY ORDERED:

- 1) For the reasons stated on the record, the Motion to Intervene is GRANTED.
- 2) For the reasons stated on the record, the Motion for Order Preserving Claimants' Rights is GRANTED in part and DENIED in part. The Motion for Order Preserving Claimants' Rights is GRANTED only with respect to the need of the Administrator to take further actions to determine claim validity as set forth in this Order.
- 3) For the reasons stated on the record, the Court hereby adopts the supplemental notice and verification procedures proposed by Class Counsel in Plaintiffs' response in opposition to the Motion to Intervene as modified below, and ORDERS the following:
  - a. The Court orders that the Administrator shall send an additional verification e-mail in response to claims that have not yet been approved or denied. The verification e-mail shall give the Claimant the option of (1) submitting a photo ID, or (2)

providing a mobile phone number capable of receiving an SMS-based text message verification code. Claimants choosing the second option shall receive a verification SMS code and enter it on the Settlement Website that would require reCAPTCHA verification.

b. Claimants shall be given at least 21 days to submit verification (as instructed in the verification email) from the date the e-mail described in ¶ 3.a. is sent. The Administrator shall send two reminder e-mails prior to the deadline.

c. Class Counsel shall provide a proposed version of the verification e-mail described in ¶ 3.a. to Chambers, via email, no later than April 17, 2023. Intervenor may object or comment on the proposed e-mail.

d. The Administrator shall follow the procedures set forth in the initial Declaration of Ryan Aldridge (dated January 18, 2023) at paragraphs ¶¶ 27–29 with respect to the verification e-mail described in this Order.

4) This matter is set for status on June 2, 2023 at 10 AM. The hearing may be joined at the following link: <https://circuitcourtofcookcounty.zoom.us/j/95535573920>. The Meeting ID is 955 3557 3920. No password is required.

5) Prior to the hearing, Class Counsel shall provide a status report of the verification campaign (with results, if available), and with appropriate affidavits of the Settlement Administrator regarding the status of the verification campaign and results (if available).
